This process will insure vessel applicant that they will be added to the Pier 32 Marina Slip Rental Wait List. Should applicant be accepted, the \$100.00 application fee will be applied to the regular deposit. Credit report will be reconfirmed if more than six (6) months old prior to vessel arrival. Please note: The marina does not accept wooden nor concrete vessels. All vessels 25 years and older require a survey.

This Application / Slip Renter sheet is a required part of your Wharfage Contract with the Marina. Please supply all requested information. In the event that there are any changes in any or all of the information contained herein, you are required to notify the Marina Office within 10 days of the date such changes become effective.

** **A "Certificate of Insurance" listing Pier 32 Marina and the Port of San Diego as the ADDITIONAL INSURED** is required prior to rental of this slip and yearly at the time of insurance renewal for as long as the vessel is moored at the Marina.

If Insurance is "Continuous" – proof of such status to be furnished to the Marina Office.

What we need:

- * Combined Single Limit Liability coverage in the amount of \$500,000 or more
- * Oil Spill and Pollution Liability listed on the Declaration page * Pier 32 Marina and the Port of San Diego named as additional insured*
- * The boat must be identified on the Declaration page (make, year, etc.)
- * Dates of coverage-we cannot accept ".....with no fixed expiration date"
- * NOTE: Progressive Insurance is unable to provide Liveaboard insurance at this time and will not be accepted if the vessel in question is designated with Liveaboard status.

*** **A current color photograph** of the vessel is required prior to approval of this application. All vessels are subject to marina manager's inspection and approval.

RENTAL RATE MEASUREMENT DIAGRAM

Bow pulpit, dinghy in davits, outboard, swim step, rudder; all must be included in LOA. Please refer to diagram below. Vessel may overhang slip by three (3) feet maximum total length overall into fairway only. Vessel may not overhang into main walk.

Rental rate is based on overall length; boat or slip length, whichever is greater. Length on deck is not an indication of overall length.
